The Board of Trustees of the Town of Del Norte, Rio Grande County, State of Colorado, met in regular session on March 13, 2019 in the Board Meeting Room, 140 Spruce Street, Del Norte, Colorado at the hour of 7:00 p.m. There being present at the **CALL OF THE ROLL** the following persons:

Her organization is a non-profit that helps spay and neuter the cats for free. She could help traps the cats and transport them to Alpine Veterinary in Alamosa who will do it for free. The animal shelter is Monte Vista will do it for \$20 a cat. Once the cats are spayed or neuter they are returned and the population will start to decrease.
